Overview



PCPNDT (Pre-Conception & Pre-Natal Diagnostic Techniques) is an act to provide for the prohibition of sex selection, before or after conception, and for regulation of pre-natal diagnostic techniques for the purposes of detecting abnormalities or metabolic disorders or chromosomal abnormalities or certain congenital malformations or sex-linked disorders and for the prevention of their misuse for sex determination leading to female feticide and for matters connected therewith or incidental thereto."

During the course of the implementation of the PCPNDT (Pre-Conception & Pre-Natal Diagnostic Techniques) Act, certain inadequacies and practical difficulties in the administration of the Act came to the notice of the Government. At the same time techniques have been developed to select the sex of the child before conception which may further the declining sex ratio. These developments were also taken note of by the Supreme Court in its various orders in CEHAT & Ors. V. UOI & Ors which is pending before the Court and the Court had also observed that amendments to the PNDT Act are necessary. After detailed deliberations, the PNDT Act has been amended with the amended Act has come into force with effect from January 2003. The main purpose has been to ban the use of sex-selection techniques before or after conception as well as the misuse of pre-natal diagnostic techniques for sex-selective abortions and to regulate such techniques.







After clicking on Change Doctor Status, the below page will appear on your screen where you have to enter your 'Control Number' -




After entering the 'Control Number', you have to click on Get OTP button. The next page will appear on your screen where you will be asked to 'Enter OTP'.



The OTP will be sent to your registered mobile number. Enter OTP and then click on Submit button.


If the entered OTP is verified, you will be redirected to the Doctor Relief Application Form. The page will appear on your screen as shown below-
